Sl. No.	The school is directed to ensure that:
1	The total number of sections of the school from class I to XII shall be restricted to 22 of which not more than 6 sections may be used for senior secondary classes. The optimum number of the students shall be restricted to 40 for a classrooms size of 500 sq ft and above. Further, increase of sections shall be subject to specific approval of the Board based on the request of the school as per affiliation bye law and availability of class rooms of greater than 500 sq ft dimension. The school is directed to run balvatika I, II & III in accordance with established norms permitted vide Board's circular no. 12/2023 dated 24-03-2023 & 25/2023 dated 11-09-2023.
2	Sexual Harassment Committee is being headed by MR. Anupam Tripathi who is a male member. As per the norms laid down in the Protection of women from Sexual Harassment at workplace Act, the committee is to be headed by a senior female employee. School shall reconstitute the committee within 03 months and submit the compliance.
3	Ramp constructed on the entrance is landing on a narrow platform which is closed end with a glass partition. The ramp is not practically usable for the wheel chair bound student. School shall remove the glass barrier/partition from front of the ramp or construct other accessible ramp within 03 months and submit compliance on SARAS portal.
4	Regular Cubicles converted into CWSN toilets but its entrance and toilet are very narrow and navigation of the wheelchair or walker is not possible inside the toilet.

	Thus, the school is required to construct the ramp and specious CwSN toilet separately for Boys and Girls with handrails on both side of toilet seat (fixed and movable) where the arrangement of classes and practical (Labs) for the CwSN is made by the School as per circular no. 11/2024 dated 09.08.2024 and proper permanent signage (on the cubicle indicating the floor number) as per the guidelines issued by the Board and the provisions laid down in the RPwD Act 2016 within 03 months and submit compliance on SARAS Portal.
5	In place of computer chairs visiting chairs are provided for working on computer in computer lab which is not appropriate. The Lab is not air-conditioned. Other required facilities such as LMS, Webcam, interactive Board, projector and speakers are also not available in the lab. School shall upgrade the lab in the light of SoP issued by the Board within 03 months and submit compliance on SARAS portal.
6	ICT infrastructure is not installed in the library. School shall install ICT infrastructure to cater the need of access digital/cloud reading material and upgrade the library in the light of SoP issued by the Board within 03 months and submit compliance on SARAS portal.
7	The school shall ensure the mandatory training of its teachers with CoE, CBSE, Bhopal within 03 months and submit the compliance.

Compliance of the above mentioned points shall be submitted within 03 months on the SARAS Portal. Failure to comply within the prescribed time shall invite financial penalty @ Rs. 50,000/- every month until compliance is submitted and shall debar the school from filling the registration and LOC of students class IX to class XII, as the case may be.

The approval of the Board as mentioned above, is subject to the following conditions:-

- 1. The school shall be responsible for its genuineness of the documents/ data/ information uploaded by the school. In case of any discrepancies, action will be initiated against the school as per Affiliation Bye -Laws-2018.
- 2. The school shall follow the RTE Act, 2009 and instructions issued thereon by the CBSE/Respective State /UT Govt. from time to time. The school will also abide by the conditions prescribed, if any, by the State Government concerned.
- 3. The School shall apply online for extension of affiliation along with the requisite fee and other documents as per Rule 10.3 of Affiliation Bye Laws.
- 4. The school shall go through the provision of Affiliation and Examination Bye Laws and subsequent amendment therein as well as circulars and guidelines /instructions issued by the Board time to time and keep a copy thereof for reference purpose and is also advised to regularly visit CBSE websites i.e., http://cbseacademic.nic.in/ & http://cbse.nic.in/ for updates.
- 5. The school shall renew mandatory certificates from time to time.
- 6. The school shall be solely responsible for any legal consequences arising out of the use of school name/logo/society/trust or any other identity /activity related to running of school affiliated to CBSE. All legal expenses incurred by the Board, if any, arising out of these circumstances, shall be borne by the school.
