- Important Notes :**
1. The total number of section of the school shall be restricted to 29 (As per prescribed dimension) as per the number of class rooms reported by the inspection committee and further increase shall be subjected to specific approval of the Board on the basis of the request of the school as per affiliation by laws.
 2. The school shall construct a hand rail along the ramp at the entrance of the building. The ramp to access the upper floors has been overlaid on stairs and appears steep. The school shall modify it as prescribed under RPwD Act or install a lift. The school shall affix permanent prescribed signage for CWSN toilets and submit compliance of all these points within 3 months on SARAS portal.
 3. The school shall ensure the training of its teachers with CoE Bhopal within the next 3 months and upload compliance on SARAS.
 4. The school should follow the SOPs laid down for labs and library and sports facilities and submit the compliance within 3 months on SARAS portal.
 5. The school is required to renew all the mandatory certificates from time to time and directed not to remove videography link in future.
